Good Afternoon Mr. Davis, welcome to the world of public service.

Perhaps you were not aware when you agreed to sit on the Board of Florida Development Finance Corp. that you were being drawn into a highly controversial issue; one with very distinct winners and those potentially bearing horrific losses.

The All Aboard Florida rail project from Miami to Orlando is seeking financing via private activities bonds, to be issued through Florida Development Finance Corp.

After several months of detailed analysis, Martin County has reached the conclusion that this project will be economically devastating to the County.

Several problems: 1.) the project will fatally constrict our marine industry as the railroad bridge is now scheduled to be closed 9+ hours of the 7:30am to 7:30pm period, minimizing movement of boats from our estuary to the ocean; Martin County has submitted details.

- 2.) the impeded vehicle traffic flow from our residential communities to our hospitals puts us in a medically untenable condition, hospital ŒO has submitted details. Our County fire/medical services cross the railroad tracks **30+ every day;** we have kept count for several years.
- 3.) municipal shopping areas effectively sealed off from our residential communities, City of Stuart and Martin County submitted details;
- 4.) commuting patterns impeded by freight and passenger train intersecting at our single track bridge adjacent to downtown Stuart. County and City have submitted details.
- 5.) all of these factors resulting in an adverse affect on our property values, Martin County Property Appraiser's Office has prepared an in depth study.

After reading the IRS description of PAB financing, I have come to understand that local governments affected by a project financed via the PAB route have the right to vote on whether or not to allow that project to come into the County.

Please be advised, Martin County is hereby posting notice of our right to vote on the All Aboard Florida project and reserving that right to vote at a later date of our determination.

So that your deliberation as a board member of Florida Development Finance Corp.will be reflective of a knowledgeable choice; please make yourself familiar with the areas of concern as documented by Martin, St. Lucie and Indian River Counties.
