Issue background:

State Law Enforcement Agencies need immediate state funding for replacement radios.

- -Most agencies, because of funding issues, are using radios that are 10-13 years old when industry-wide useful life expectancy is only 7 years.
- -For state agencies, over 14,000 mobile and portable radios have exceeded end-of-life/end-of-support status. Similarly, third party users have nearly 2,900 radios in end-of-life / end-of-support status.
- -The State?s first responders require a radio refresh to comply with Florida policy for technology refreshment.

The SLERS Joint Task Force directive in its Strategic Planning Report May 19, 2014:

?SLERS state agencies and additional subscribers are advised to purchase adequate stock of EDACS equipment to meet their needs for the period leading up to completion of the new system, which could extend to the end of the current contract on June 30, 2021. Any newly manufactured radio equipment purchased must be P25 Phase II compliant.?

DMS Report to Legislature December 12, 2009:

?The equipment lifecycles for handheld and vehicle units are typically 6 years for handheld and 8 years for vehicle.?

-SLERS users also require a radio refresh for P25

DMS Business Case Study January 28, 2015:

?To move forward with a P25 system upgrade, all existing EDACS-EA radios will need to be replaced with P25 radios to operate on the new system.?

- ? Today, more than 17,000 radios are currently beyond useful lifecycle and manufacturer support.
- ? To allow time for programming, training and deployment, user agencies will need to begin now to refresh SLERS radios.
