Re: Florida Trial Lawyer Political Contributions 2014-16

This memo presents summary information regarding political contributions made by a selected group of politically active trial lawyers/law firms to Florida candidates and committees – including contributions made by the Florida Justice Association, the trade association representing trial lawyers in the state. This memo includes data pertaining to all contributions from these sources to other candidates/committees from January 1, 2014 to August 31, 2016. A spreadsheet containing details of each individual contribution accompanies this memo as a separate Excel file.

Project Methodology

We began this project by identifying 125 politically active law firms that represent plaintiffs in personal injury, medical malpractice, mass tort, and other types of litigation. The list of firms was selected based on several criteria, including firms that have been major contributors to the Florida Justice PAC, to the Charlie Crist for Governor Committee, to state party committees, and to several other political action committees. Three of these firms are located outside of Florida (Mostyn Law Firm in Houston; Clark, Love & Hutson in Houston; and Chestnut Firm in Atlanta). The list also includes firms with principals serving as officers of the Florida Justice Association.

For the 125 firms on the list, we identified geographic location and key lawyers based upon a search of each firm's website. The full list of law firms, key lawyers, and related information is provided below as Appendix A. Note that this list of trial lawyers/law firms that are politically active in Florida politics is not meant to be comprehensive. Thus, it only represents some fraction of the total political contributions made by trial lawyers and their law firms from January 1, 2014 to August 31, 2016. Note also that with just two exceptions (Anne Pajcic and Sallyn Pajcic who both contributed hundreds of thousands of dollars) the list of contributions does not include spouses or other parties found at the same physical address as some of the individual attorneys identified in this memo.

We used the database on the Florida Secretary of State/Division of Elections [website](#) to search for contributions made by each of the 125 law firms and the key lawyers identified for each of these firms. As indicated above we limited the search period and only retrieved contributions made from January 1, 2014 to August 31, 2016. We downloaded the results of all searches of the Florida Secretary of State/Division of Elections database into an Excel file. Once the final list of contributions was compiled from each of the relevant firms and key lawyers, we added columns titled "Contributor Group" and "Type" to aggregate individual lawyers together with their respective law firms. We also added columns titled "Party" and "Class" to aggregate certain types of contribution patterns.

Significant Finding #1 – Total Contributions from Trial Lawyers/Law Firms of nearly \$21 Million

Searches of the Florida Secretary of State/Division of Elections database show that the 125 law firms and their respective key lawyers in question contributed a total of \$20.9 million to candidates and all other committees (including Florida Justice PAC) from January 1, 2014 to August 31, 2016. Of this total amount contributed:

- \$17.1 million was contributed to a variety of candidates and committees in Florida
- \$3.8 million was contributed to Florida Justice PAC (controlled by the Florida Justice Association)

Searches of the Florida Secretary of State/Division of Elections database show that the Florida Justice PAC contributed a total of \$3.4 million to a variety of candidates and other committees (this excludes contributions made from the Florida Justice Association to the Florida Justice PAC) from January 1, 2014 to August 31, 2016.

Thus, the 125 law firms, their key lawyers, and the Florida Justice PAC contributed a total of \$20.5 million to candidates and other committees in Florida (\$17.1 million + \$3.4 million) from January 1, 2014 to August 31, 2016. As indicated, this particular calculation backs out the \$3.8 million of contributions that the 125 firms/key lawyers gave to Florida Justice PAC in order to avoid double counting that money.

Significant Finding #2 – Top 4 Law Firms Each Contributed more than \$1 Million; Top 10 Law Firms Each Contributed more than \$400,000

The following table shows contribution totals aggregated by the top 10 law firms and their key attorneys (“Contributor Groups”). Each of these top 10 firms contributed more than \$400,000 from January 1, 2014 to August 31, 2016. The table further breaks down the data by election cycle (2014 and 2015-16). The top 4 law firms each contributed more than \$1 million. As noted previously, a detailed list of contributions accompanies this memo as a separate Excel spreadsheet file. A tab of that spreadsheet titled “Conts By Law Firm” shows the aggregated totals for all 125 firms.

Significant Finding #3 – Largest Recipient in 2014 Was Charlie Crist for Governor Super PAC; Largest Recipient in 2015-16 Cycle Is Other Super PACs

The following table provides a summary (shown by Class of recipient) of the \$20.5 million of contributions made by the 125 law firms, their representative partners, and Florida Justice PAC to candidates and committees from January 1, 2014 to August 31, 2016. The table further breaks down the data by election cycle (2014 and 2015-16). As shown in the table, contributions to political committees (PAC) were much higher in 2014 than in 2015-16 – driven mainly by the Super PAC that supported Charlie Crist’s gubernatorial campaign in 2014. By contrast, contributions to legislative candidates (STS and STR) are significantly higher in 2015-16 than in 2014.

The top 15 recipients of contributions from the 125 law firms, their key lawyers, and the Florida Justice PAC from January 1, 2014 to August 31, 2016 are shown in the following table. As shown in this table, the Super PAC formed to support Charlie Crist’s run for governor in 2014 received \$9.5 million. Contributions directly to Crist totaled more than \$256,000. Party committees received more than \$3.8 million in contributions.

Significant Finding #4 – Contributions to Partisan Officials/Committees Favored Democrats over Republican by Margin of 18 to 1 in 2014, But Evenly Split in 2015-16

During the entire January 1, 2014 to August 31, 2016 period, the 125 law firms, their key lawyers, and Florida Justice PAC gave overwhelmingly to Democratic candidates and committees in those instances where a partisan affiliation was indicated. Note that the total contributed to Democrats includes contributions made to the Charlie Crist for Florida Super PAC and DGA-Florida PAC. Other PACs are excluded from consideration in this table.

Importantly, this partisan skew was driven primarily by contributions made to the Super PAC that supported Charlie Crist’s gubernatorial campaign in 2014. To wit, contributions to Democrat candidates and committees in 2014 outweighed contributions to Republicans by a margin of more than 18 to 1. In 2015-16, the partisan skew disappeared entirely.

Significant Finding 5 – There Were 36 Separate Contributions of at least \$100,000

As a final point, it is worth noting that there were 36 separate contributions of \$100,000 or more made by the 125 law firms, their key lawyers, and Florida Justice PAC. (Note that this table includes contributions made to the Florida Justice PAC and by that PAC to other committees.) As shown in the first table, 8 of these \$100,000 or more contributions were made during the 2015-16 election cycle, while the second table shows the remaining 28 that were made during 2014.
