DECLARATION OF MARION P. HAMMER

I, Marion P. Hammer, pursuant to 28 U.S.C. § 1746, hereby declare as follows:

- 1. I am a citizen of the United States and a resident and citizen of Florida. I am competent to testify, and I make this Declaration based on personal knowledge of the facts stated herein which I declare to be true and correct under penalty of perjury.
- 2. I am a former President of the National Rifle Association of America, Inc. ("NRA"), and I frequently represent the NRA's interests in the State of Florida. I have provided assistance to the NRA in preparing this lawsuit, and I have been identified in national news stories associated with the suit.

- 3. After news of the Parkland shooting broke, I received numerous harassing emails and phone calls threatening my life and physical well-being. Those threats continue to this day. Attached as Exhibit 1 to this Declaration are true and correct copy of 14 such emails, which are representative of the scores of other threatening emails I have received.
- 4. One email, for example, referred to me as a "Tw*t" and "a vile c**t" and stated that "I love that you freaks always get taken down eventually." See Exhibit 1 at 1. Another individual called me a "nasty old 'f**king piece of sh*t" and stated "Blood on your hands, you're going down." See id. at 4. Another representative email states that "Next time I hope it's someone in your family looking down the barrel of a gun or shot in the back trying to flee some great Floridian." See id. at 11.
- 5. I have also received scores of threatening and harassing phone calls from individuals who have used offensive and derogatory language, some of whom have threatened my life and physical well-being.
- 6. I have worked with the NRA and its attorneys in this litigation to help identify 18-to-21-year-old Florida residents who may be interested in participating in the lawsuit. Many of the individuals I have spoken with are afraid of the harassment and threats they would be exposed to were they to

become publicly associated with the litigation and have refused to participate because of these concerns.

I declare, under penalty of perjury, that the foregoing is true and correct.
